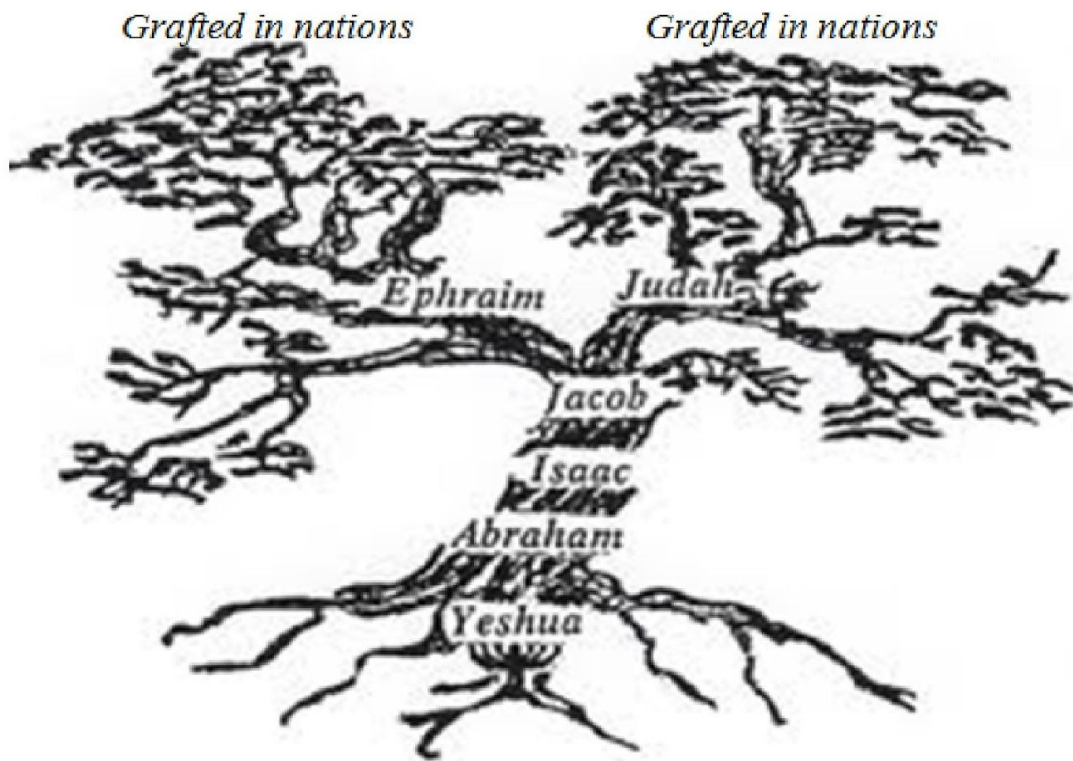

Purpose

HOI exists for the purpose of fulfilling the biblical mandate of the Most High in the following areas:

- 1) To make disciples of all people
- 2) To serve as a vehicle of the Holy Spirit providing and preserving the unity of the saints
- 3) To serve as a fellowship association and network for congregations and ministries assisting them in growth and edification
- 4) To assist in bringing the people of Elohim to the measure of the stature of the fullness of Messiah according to Ephesians 4:11-12
- 5) To promote the keeping of the Seventh day Sabbath, and the annual appointed times of YHWH according to Leviticus ch. 23.

Services Provided

1) Information and assistance toward maintaining a legally sound ministry

3) Ministry Licensing and Ordination

Those called to ministry seeking to obtain credentials may do so provided they maintain a lifestyle that is consistent with the biblical standards of morality as outlined in the Holy

Scriptures.

4) Spiritual Covering

Spiritual covering is available to provide spiritual government for ministers, congregations and ministries. Spiritually mature leaders with Biblical integrity shall provide advice, counsel and spiritual restoration. All matters of moral failure shall be addressed in a manner leading to spiritual restoration without the threat of being improperly exposed.

5) Biblical counsel through seminars producing "wholeness" in all areas of life such as:

- * Financial planning
- * Health and nutrition
- * Marriage and the family
- * Manhood: being a man of God
- * Womanhood: being a woman of God

6) Spiritual Counseling

Levels of Association

Covenant Partner Affiliate: Individuals, congregations and ministries that are in agreement/covenant with the vision and purpose of HOI.

Covered Covenant Affiliate: Individuals, congregations and ministries that have spiritual covering from the leadership of HOI.

Sowing and Giving

Covenant Partners of the fellowship should sow into the fellowship as they have purposed to give.

Covered Covenant Affiliates receiving spiritual covering should follow the biblical principle of tithing (from the congregation or one's salary received from the congregation).

Annual Meetings

Annual Meetings will be held according to the Biblical Feasts (Appointed times) of YHWH.

MEMBERSHIP REQUIREMENTS FOR ORDAINED MINISTERS AND MINISTRIES

1) Accept the Vision, Mission and Statements of Faith

2) Submit to Spiritual Covering

The spiritual covering of the HOI Fellowship does not seek to be a lord over YHWH's heritage. Rather, the Spiritual covering is to provide leadership through the love of Messiah to all the ministers and ministries under the covering. The purpose of the spiritual covering is defined by the following:

- a) To assist the minister to maintain biblical integrity
- b) To provide spiritual government in accordance with Scripture.
- c) To provide advice, counsel and spiritual restoration. All matters of moral failure shall be addressed in a manner leading to spiritual restoration without the threat of being improperly exposed. For the spiritual covering to be effective, the minister must voluntarily submit to the leadership of the Spiritual covering.

3) Financial Responsibility

Tithing (the tenth or 10% of one's increase/income) is a biblical requirement for all believers within the framework of the New Covenant and it is connected to the Melchizedek Priesthood in Messiah. The minister is called to be an example of the believer in ALL things. In following the biblical command it is a requirement of ministers to tithe.

The local pastors are to pay the tithe (10%) from the total of tithes received from the local congregation and send it to the Regional Overseer. Local pastors in regions without Regional Overseers are to send the tithe to the office of the General Overseer. (Numbers 18:25-28; Hebrews 7:7-8; 1 Corinthians 9:13-14)

The Regional Overseer is to pay the tithe (10%) from the total tithes received from the local pastors and send it to the office of the General Overseer. (Numbers 18:25-28; Hebrews 7:7-8; 1 Corinthians 9:13-14)

Ministers that do not tithe are robbing/defrauding God and not being an example of the believer in faith. Tithing reveals that a minister has submitted their finances to YHWH. HOI seeks to maintain the highest integrity for its spiritual leaders before the Most High. HOI will not support or cover ministers that demonstrate continued disobedience in this area.

VISION & MISSION

We are a ministry concerned about the lives of people being made whole and believe that the Most High has raised us up to perpetuate the ministry vision of Yeshua (Jesus) the Messiah to make disciples of all nations (ethnic people groups).

We believe that it is essential that all believers be taught the following three things:

- 1) The Roots of the Faith in Messiah - To know where we came from
- 2) The Future Destiny to Rule with Messiah - To know where we are going
- 3) To observe ALL that Messiah has commanded - To stay on course until we reach our destiny in Messiah

Scripture reveals that the Messianic Community has been given the charge to continue the ministry of Yeshua (Jesus) the Messiah in the earth. This is characterized by:

- * Declaring the good news of the Kingdom Of Elohim.
- * Making disciples of all people.
- * Equipping the believer to do the work of ministry.
- * Ministering to the needs of the afflicted, disadvantaged, imprisoned & the spiritually weakened to bring them to a place of wholeness.

STATEMENTS OF FAITH

We believe that God is One - a composite oneness (Elohim echad). That His name is YHWH, meaning the self existent one. That He is eternally existent in the Father (HaAbba), the Son (HaBen) and the Holy Spirit (HaRuach HaKodesh).

We believe in Yeshua (Jesus) the Messiah (Christ) of Israel and Son of God (ben Elohim). That He is YHWH manifested in the flesh, born of a virgin, being fully human and fully divine, who was crucified, buried, resurrected on the third day, and has ascended to sit on the right hand of the Father.

We believe in the Holy Spirit (HaRuach HaKodesh) - the Spirit of YHWH. That He is the promise of the Father sent by the request of Yeshua the Messiah to empower, comfort, teach, and guide in truth the New Covenant People of God.

We believe in the Holy Scriptures according to II Tim. 3:16 that all scripture is given by the inspiration of God (God-breathed) and is profitable for doctrine, reproof, correction and instruction in righteousness. Accepting both the Tanakh - Torah, Prophets and the Writings (Hebrew Scriptures containing Genesis thru Malachi) - and the Brit Chadashah (New Covenant Scriptures) as our rule of faith, practice, government and discipline.

We believe that salvation from sin has been provided for mankind through the redemptive work (death, burial and resurrection) of Yeshua the Messiah according to the grace of God.

We believe in water baptism for the believer (Matthew 28:19; Mark 16:16).

We believe that there is only one People of God revealed in the scriptures as the following: Israel, Israel of God, the body of Messiah (Christ) and the Congregation (ekklesia) of God. That it is composed of “all people” (Isaiah 56:7-7); both Hebrew believers and believers formerly called Gentiles that are grafted into “the Olive tree” (Romans 11:17). That it is the will of God for the Hebrew people that are unbelievers to be “grafted back” into their Olive tree if they have faith in Yeshua as the Messiah (Romans 11:23-24).

We believe that the People of God are under the New Covenant through Yeshua the Messiah.

We believe in the unity (echad) of all believers in the Messiah (John ch. 17; Ephesians 4:3-5).

We believe in the operation of the Gifts of the Holy Spirit, and the manifestation of miracles, signs and wonders. (I Corinthians ch. 12).

We believe in the Five-fold ministry of the Apostle, Prophet, Evangelist, Pastor and Teacher (Ephesians 4:11-12).

We believe that occupancy in the five-fold ministry leadership offices is not based upon gender or ethnicity, but based solely upon the call of God to use redeemed human beings in His service. Since the Torah is not gender exclusive pertaining to spiritual leadership, we believe any believer called of God can occupy the five-fold ministry offices.

We believe in the observance and celebration of the Feasts of YHWH recognizing their significance and fullness in Yeshua the Messiah (Leviticus ch. 23; Colossians 2:16).

We believe that the Shabbat (Sabbath), the seventh day of the week, is the created holy day of YHWH, which He gave to mankind and covenanted with His people as a sign forever. Also that the Shabbat points to the eternal rest for the people of God to be fully realized in the visible kingdom of Messiah (Exodus 31:16; Genesis 2:2-3; Isaiah 58:13-14; Matthew 12:8; Hebrews 4:9-11).

We believe in financial stewardship through practicing tithing and giving. That tithing continues under the new covenant and is received by Yeshua the High Priest after the order of Melchizedek. In tithing we honor God with the tenth of our substance. In giving we honor God by sowing cheerfully into His kingdom and reaping from what has been sowed (Leviticus 27:30-32; Hebrews 7:7-8; Proverbs 3:9; II Corinthians 9:6-7).

We believe in the pre-millennial second coming of Yeshua the Messiah (Revelation ch. 19 & 20).

We believe in the resurrection of the righteous to everlasting life, and the resurrection of the unrighteous to everlasting punishment in the lake of fire (Daniel 12:2; Revelation ch. 20).

We believe in the use of the name of God such as Yahweh, Yahwah and Yahuwah. Also we accept the use of Yeshua and Yahshua for Messiah. Although we hold preference and promote the use of Messiah's original Hebrew name, we do not reject the use of his name translated from the Greek term "Iesous". We believe "Iesous" is the Greek transliteration for the Hebrew "Y'shua" in a Greek masculine form. We do not believe that "Iesous" is a pagan name as others may hold for it was used by Paul the Apostle in his letters that later became part of the scripture.

We believe in the divine institution of marriage exclusively between a man and a woman according to Genesis 2:23-24.
